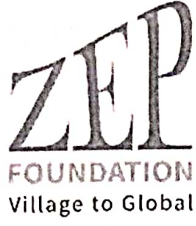




WHEREAS:


1. Sessions on Financial Literacy are for one hour of duration.

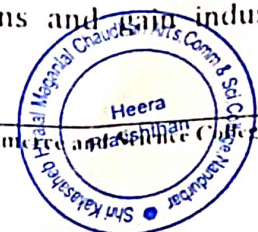

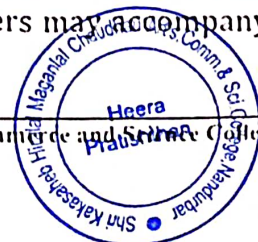


